MSP to approve the agenda with the addition of CARES Act discussion. MSP to approve the consent agenda.

MSP to approve the 2020 DNR Boar and Water Safety Grant agreement in the amount of \$1,115 effective January 1, 2020-June 30, 2021.

MSP to approve the quote from Floor to Ceiling in the amount of \$22,174 to replace carpet in the LEC commons area. The cost will be shared with the City of Marshall paying 49% of the cost and the County paying 51% of the cost.

MSP to award SAP-042-611-046/SAP 042-606-012 to Midwest Contracting LLC based on the low bid of \$248,263.10 and authorize County Administrator and Board Chair to sign contract.
