



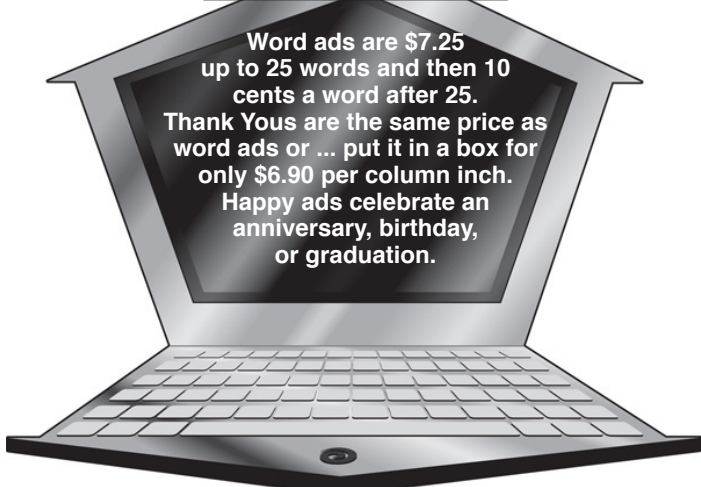

MSP to cast a unanimous ballot to nominate Gary Crowley as Board Chair for 2019. Motion passed with Commissioners Anderson, Graupmann, Ritter and Sanow voting in favor. Commissioner Crowley abstained from voting.

MSP to cast a unanimous ballot for Steve Ritter as 2019 Vice Chair. Motion passed with Commissioners Anderson, Crowley, Graupmann and Sanow voting in favor. Commissioner Ritter abstained from voting.

MSP to approve the agenda with the additions of application for cancellation of forfeiture and committee appointment discussion.

MSP to approve the consent agenda.

MSP to approve the 3-year proposal for the official newspaper as 2019 Minneota Mascot, 2020 Marshall Independent and 2021 Tracy Headlight Herald.
