



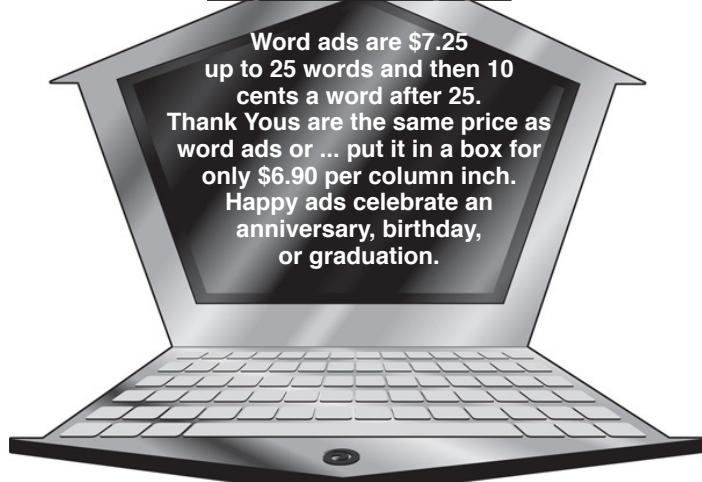

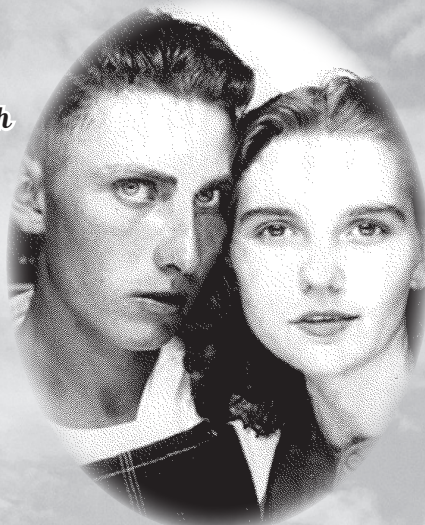

Said bids to be for the furnishing of all labor and materials for the construction and installation, complete in place, for the Twin Lakes County Park Phase II Development Project. The work shall include, but will not be limited to, the following:
