



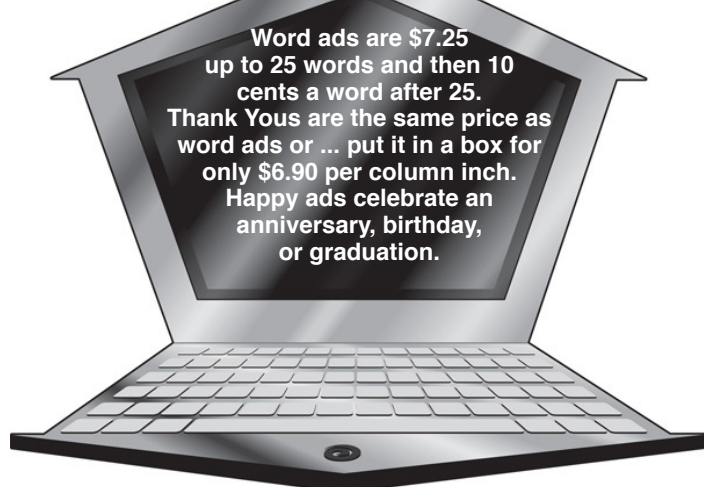

### NOTICE OF FINAL HEARING IMPROVEMENT AND REDETERMINATION OF BENEFITS MURRAY-LYON-REDWOOD COUNTY JUDICIAL DITCH NO. 20A MURRAY COUNTY JUDICIAL DITCH NO. 6

The Murray, Lyon and Redwood County Joint Drainage Authority Board for Judicial Ditch No. 20A, and the Murray County Drainage Authority Board for Judicial Ditch No. 6 finds as follows: that a Petition for the Improvement of Branch 24 of Judicial Ditch No. 20A and the Main Tile and Branch 1, Branch 2 and Branch 5A of Judicial Ditch No. 6 are pending; that the Engineer's Detailed Survey Report has been filed; that the Viewers' Report has been filed. These two systems are interconnected, in that the Branch 24 tile of Judicial Ditch 20A acts as the outlet for Judicial Ditch 6.

The Murray, Lyon and Redwood County Joint Drainage Board establishes: Wednesday July 17, 2019 at 4:30 p.m., in the Commissioners Room of the Murray County Government Center, Slayton, MN as the time and place for the Final Hearing on the Improvement of Branch 24 of Judicial Ditch No. 20A and the Main Tile and Branch 1, Branch 2 and Branch 5A of Judicial Ditch No. 6. Also to be considered is a Viewers' Report for a Redetermination of Benefits.

Judicial Ditch No. 20A provides drainage to portions of 26 Sections in Shetek Township, Murray County; portions of 2 Sections in Holly Township, Murray County; portions of 1 Section in Lake Sarah Township, Murray County; portions of 1 Section in Custer Township, Lyon County; portions of 13 Sections in Monroe Township, Lyon County; and portions of 2 Sections in Springdale Township, Redwood County. The proposed improvement will consist of the following:

**Branch 24:** The Branch 24 tile from Judicial Ditch 6 to the open ditch of Judicial Ditch 20A is proposed to be improved with tile ranging in size from 36" to 42".

**Branch 24C:** the Branch 24C tile is proposed to be improved with tile ranging in size from 8" to 12".

Judicial Ditch No. 6 provides drainage to sections 5, 6, 7, 8, 9, 17 and 18 of Shetek Township, Murray County. The existing outlet for Judicial Ditch 6 is into the Branch 24 tile of Judicial Ditch 20A. The proposed improvement will consist of the following:

**Main Tile:** The Main Tile is proposed to be improved with tile ranging in size from 15" to 36"

**Branch 1:** The Branch 1 Tile is proposed to be improved with tile ranging in size from 10" to 18"

**Branch 2:** The Branch 2 Tile is proposed to be improved with tile ranging in size from 12" to 24"

**Branch 5A:** The Branch 5A tile is proposed to be improved with tile ranging from 12" to 15"

The following is a map of the proposed Improvement of Judicial Ditch 20A and Judicial Ditch 6, which lies over parts of Shetek, Holly and Lake Sarah Townships, in Murray County, Custer and Monroe Township in Lyon County; and Springdale Township in Redwood County; along with the names of land owners in each Section and each political subdivision that may be affected.
