MSP to approve the agenda.

MSP to approve the consent agenda.

MSP to accept a \$10 donation from Grant Schwedenmann to be placed in the DARE account. A thank you will be sent.

MSP to approve and authorize appropriate parties to sign the Des Moines River Watershed Partnership Joint Powers Agreement.

MSP to approve submission of the Des Moines River Watershed Comprehensive Watershed Management Plan (2023-2032) to the Minnesota Board of Water & Soil Resources.

MSP to approve the CUP for 5 Family Ranch wedding barn with the recommendations presented.

MSP to enter into an agreement with the State of MN for the Legacy Grant for projects in Garvin Park as discussed. Motion carried with Commissioners Crowley, Graupmann, Ritter and Sanow voting in favor. Commissioner Anderson abstained from voting.

Homestead Notice

IMPORTANT PROPERTY TAX HOMESTEAD NOTICE

This will affect your 2023 property taxes and eligibility for Property Tax Refund.

Have you purchased or moved into a property in the past year?

Contact your county assessor to file a homestead application if you or a qualifying relative occupy the property as a homestead on or before December 31, 2022.

What is a qualifying relative?

For unoccupied agricultural property, a qualifying relative includes the child, grandchild, sibling, or parent of the owner or owner's spouse.

For occupied agricultural or residential property, a qualifying relative also includes the owner's uncle, aunt, nephew, or niece.

When do I apply?

You must apply on or before December 31, 2022.

Once homestead is granted, annual applications are not necessary unless they are requested by the county assessor.

Contact the assessor by December 31, 2022 if the use of the property you own or occupy as a qualifying relative has changed during the past year.

If you sell, move, or for any reason no longer qualify for the homestead classification, you are required to notify the county assessor within 30 days of the change in homestead status.

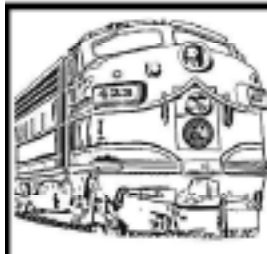
