



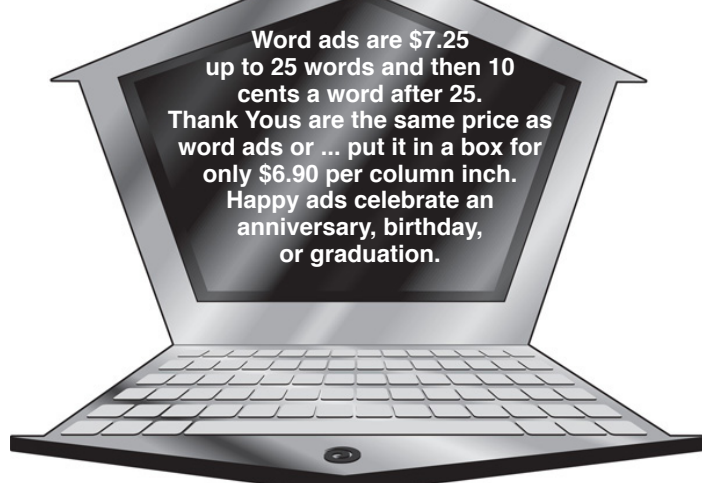

A Summary of the Proceedings of the Lyon County Board
9:00 a.m. pursuant to notice the Lyon County Commissioners met with the following members present: Commissioners Crowley, Anderson, Sanow and Ritter. Members absent: Commissioner Graupmann. Also present: Administrator Stomberg and County Attorney Maes.

MSP to nominate Gary Crowley as Board Chair for 2020. Motion carried with Commissioners Anderson, Graupmann, Ritter and Sanow voting in favor. Commissioner Crowley abstained from voting.
MSP to nominate Stephen Ritter as Vice Chair for 2020. Motion carried with Commissioners Anderson, Crowley, Graupmann and Sanow voting in favor. Commissioner Ritter abstained from voting.
MSP to approve the agenda with the addition of Fair Board discussion.
MSP to approve the consent agenda.
MSP to designate HYPERLINK "http://www.lyonco.org" www.lyonco.org as the official publication for advertisement for bids for transportation related projects.
MSP to approve the Yankton Nexamp Solar CUP with the added stipulation of an amount of \$25,000 cash with an immediate \$5,000 and at the end of 5 years there will be an infusion of \$10,000 and explanation of decommissioning and at the end of 15 years have another infusion of \$10,000 and an explanation of the decommissioning process. The condition applies to future owners.
